Proceedings of the 2<sup>nd</sup> Meeting of Executive Committee (EC), Himachal Pradesh Agricultural

Development Society for HP Crop Diversification Promotion Project, Phase-II held on 16<sup>th</sup>

November, 2021 at 4:00 PM at Dharamshala under the Chairmanship of Dr. Ajay Sharma,

Secretary (Agriculture) to the Govt. of Himachal Pradesh.

#### List of the participants us given at Appendix-"A"

At the outset, a warm welcome was extended to the Chairman EC, Chief Representative of JICA India & JICA team, Additional Commissioner, Ministry of Agriculture & Farmers Welfare, Director of Agriculture and other members of the Executive Committee. Thereafter, the Project Director presented following agenda items for discussion.

## Agenda No.1: Confirmation of the minutes of last meeting held on 5th May, 2021.

The proceedings of the 1<sup>st</sup> EC meeting of Phase-II of HPCDP held on 5<sup>th</sup> May, 2021 through virtual mode were confirmed as no comments were received from any member.

### Agenda No.2: Action taken report on 1st EC meeting.

The Project Director apprised the house that Loan effectuation was done on 21<sup>st</sup> July, 2021, however, the project started expenditure from June, 2021 and started filing reimbursement claims from August, 2021 onwards. Reimbursement claims of Rs. 2.98 Crore have been filed till date. It was also informed that all the Project Management Units (PMUs) have been set up and are operational. There are 4 DPMUs (Hamirpur, Mandi, Kangra and Solan) and 14 BPMUs (Hamirpur, Una, Mandi Sarkaghat, Gohar, Kullu, Palampur Dharmshala, Dehra, Chamba, Solan, Rampur, and Nahan) set up for effective implementation of the second Phase of HPCDP. As far as staff deployed for second phase is concerned, 39 Nos. Department of Agriculture (DoA) staff of different categories is deployed in the project against 62 agreed DoA staff. The Chief Project Advisor, HPCDP requested the Chairman EC and Director Agriculture to post remaining DoA staff to the project so as to gear up the work. It was also informed that, so far, services of 137 outsourced employees have been hired in the first batch and requisition for remaining categories of staff has been placed with the outsource agency.



- The services of Architect for designing and estimation of construction works, agency for Survey investigation and preparation of DPRs, Chartered Accountants, Agency for Conducting Baseline survey have already been hired after following JICA procurement guidelines through competitive bidding.
- As per the laid down procedures in the MoD, for selection of Project Management Consultants (PMC), RFP document is being issued to the shortlisted five consultant firms and after evaluation, concurrence from JICA, India shall be obtained and the evaluation will be completed by the month of March, 2022 as per agreed timeline and PMC shall be in place in March, 2022. As per approval accorded in the 1<sup>st</sup> EC meeting, an independent evaluation committee has been constituted. Further, in order to complete this complex process of Hiring of PMC in a time bound manner and to address the pre-bid queries, drafting of Project Operational Manual for Phase-II of the project, the services of an expert, have been hired by the project w.e.f. 1<sup>st</sup> September, 2021 to 30<sup>th</sup> April, 2022 through single source selection. The EC accorded its ex-post facto approval for hiring of services of expert Mr. G.S. Raju.
- Review of Physical and financial progress for the year 2021-22: -The Project Director informed the house that as per the project phasing of nine years, the Annual Plan of Operation (APO) amounting to Rs. 53.97 Crore was prepared for the year 2021-22, however, the GoHP has allocated the funds to the tune of Rs. 20 Crore for the FY 2021-22 and APO was revised to Rs. 20 Crore. Accordingly, the detailed physical & financial targets vis-a vis achievements made so far, are given as Annexure-"1". The Chairman asked the Project Director to seek additional allocation after utilization of the allocated funds.
- The agenda regarding handling over of six collection centres along with 5 retail outlets to FPC HAVi for O&M was discussed in length and after detailed deliberations, it was directed by the Chairman, EC to submit the latest financial status of FPC HAVi i.e. whether any profit is being earned by HAVi or still HPCDP is looking after its recurring operational expenses. Further, he directed the Project authorities that complete detail of formation of FPC, membership, utilization of seed money / one time hand holding

support (Rs. 35 lakh) given to HAVi from Project side, other expenditure incurred from the project on infrastructural and other contingency expenditure along with GUC, balance sheets and audited financial reports of previous years be submitted to him immediately and no further financial & hand holding support is to be offered to HAVi since Rs 35 lakh already given to HAVi is a huge sum in a small state. The representative of JICA India also asked to share these financial viability details, sustainability status of HAVi with JICA India office. The Chairman, EC also enquired about the status of Draft MoU (Annexure-"2") between HPCDP and HAVi, to which the Chief Project Advisor, HPCDP informed that after incorporating all the suggestions of law Department, GoHP, the draft MoU has been submitted to the Administrative Department on 14<sup>th</sup> October, 2021. The Chairman asked the Project Director to submit financial viability status of HAVi and other details as mentioned above before proceeding to signing of MoU and handing over of assets to HAVi.

#### Agenda No. 3: Technical Approval of DPRs till PMC is in Place.

The Project Director explained that as per provisions of MoD, the Detailed Project Reports of the infrastructural works need to be approved from Project Management Consultants (PMC). As already submitted, the hiring of PMC is in progress and the services of PMC are likely to commence from April, 2022 as per agreed terms & conditions. Therefore, as requested, the EC granted its approval to get the detailed project reports of different construction related activities technically approved from the Superintending Engineer (Soil Conservation) of Agriculture Department till the PMC is in place.

#### Agenda No. 4: Maintenance of Project Accounts through tally software.

The Project Director requested the EC to grant approval for maintaining project accounts of different PMUs (SPMU, DPMUs and BPMUs) through double entry system of accounting through Tally software. To this, the Additional Chief Development Specialist, JICA, India, suggested that the tally software is outdated. Now a days, ERP (Enterprise Resource Planning) software is in use and he suggested that the project should go with ERP software instead of Tally software. After discussion, it was decided that ERP software will be used for maintaining Project Accounts in second Phase of HPCDP.

Further, he also highlighted the importance of MIS/GIS system in the project being the need of the hour. The Chairman, EC, instructed the project authorities that some young officers of Department of Agriculture as well as HPCDP should be trained in MIS / GIS so that they can handle these systems of the project for next 8-10 years. The Managing Director, HPSAMB suggested that the work of MIS/GIS can even be outsourced to any professional agency as there is already shortage of staff in the Department. So, the project should work on both the options.

#### Agenda No. 5: Shifting of BPMU office from Dehra to Birta (Kangra)

The Project Director informed the house that presently, BPMU Office Dehra is running in hired accommodation at Dehra for which monthly rental of Rs. 11,633/- is being paid. Due to increase in staff strength in phase-II from 12 to 25 per BPMU, it is not possible to accommodate whole BPMU staff in the present accommodation. Moreover, there is enough space available with the project for accommodating BPMU Dehra staff at Birta Kangra. Also, more than 50 percent selected sub projects for execution during second phase under BPMU, Dehra are in a radius of 10 kms from the said premises. So, it was proposed that the BPMU office be shifted from Dehra to Birta. To this, EC gave approval and further added that shifting of BPMU office to the proposed place will not only add to efficient implementation of project activities but also saving of project funds.

#### Agenda No. 6: Relaxation in qualification/experience of certain staff continued from Phase-I

The Project Director apprised that the Project has retained all experienced staff of Phase-I of Project. In Phase-II, in certain categories there are minor variations in the qualification/experience of few categories although they have been working and performing same duties as in the Phase-I project. The on file approval for relaxation in qualification/ experience of some staff as per **Annexure-"3"** was already accorded by the Chairman, EC. The EC accorded approval to the proposed relaxations alongwith relaxation in age/ experience in case of driver, senior design engineer.

## Agenda No. 7: Approval to spend Rs 20 lakh out of society funds for launching event of Phase-II of HPCDP & Field Visit

The Project Director informed that during 15<sup>th</sup> EC meeting of Phase-I, it was approved by the EC to utilize funds amounting to the tune of Rs. 9.06 Crore out of society funds for execution of different approved project activities. Funds amounting to Rs. 7.29 Crore have been utilized, so far, thus leaving a saving of Rs. 1.77 Crore due to Covid pandemic as the field trainings/ exposure visits could not be organized. He requested EC to grant its approval to utilize funds to the tune of Rs. 20 Lakh for organizing the event on closing of Phase-I and launching of Phase-II of HPCDP. Rest of the expenditure on the Launching event and field visit shall be incurred from the appropriate activities of the project funds. The EC approved to utilize the funds out of society funds for this event Rs. 20 Lakh as proposed or actual expenditure after adjusting the expenditure eligible under the project.

# Agenda No. 8: The comments and suggestions from the Chairman, members of the EC, representatives from JICA and Ministry of Agriculture & Farmers Welfare Govt. of India

i) The Managing Director, Himachal Pradesh State Agriculture Marketing Board informed that funds have been earmarked for up gradation of 13 existing market yards in Phase-II of HPCDP under Value Chain and Market Development component of the project. Accordingly, funds are being released from project side. Due to recent heavy rains in the state, huge landslide has occurred near Bhattakuffer site of Agriculture Produce Market Committee (APMC) Shimla and Kinnaur and it is not feasible to execute proposed upgradation of the said market yard. HPSAMB has also got the site surveyed from experts of IIT, Mandi and they have also declared the proposed site "unsafe". Therefore, HPSAMB proposes to upgrade Nohradhar Market yard in District Sirmaur under APMC, Paonta Sahib instead of already proposed Bhattakuffer market yard. The Chairman EC informed that since the area is also known as Garlic hub of the State, therefore, the upgradation of Nohradhar Market yard will definitely add to the facilities being provided to the farmers of the area. The Managing Director, HPSAMB further added that upgradation of the Nohradhar market yard will be done as per already approved funds and no additional funds for this will be demanded from project. The JICA representative informed the house that since there is no change in scope of work and only location of work will change, accordingly, a proposal in this case may be submitted to JICA, India through HPCDP for approval. Thus, the EC approved the proposal mooted by the Managing Director, HPSAMB.

Additional Commissioner, Ministry of Agriculture & Farmers Welfare, Govt. of India, Dr. O.P. Sharma suggested the need of training of Project Extension staff on Integrated Pest Management at National Institute of Plant Health Management, Hyderabad. This will facilitate the extension officers to further disseminate IPM practices amongst the farming community of the State. To this, the Chairman, EC agreed and said that being National Level Institute, we can send our officers and train them as master trainers. The Chief Project Advisor, HPCDP suggested that there should be a mixed team of DoA Officers and Officers from project side for said training course. The Director of Agriculture agreed to the proposal.

The Chief Representative, JICA India expressed his satisfaction on the steps taken by the project, so far and said that the project should now gear up to start project activities.

## Memorandum of Understanding

This Memorandum of Understanding is made on this Day of 2021, at Hamirpur,

PMU, Agriculture Complex, Distt. Hamirpur, H.P. PIN Code- 177001 (hereinafter reference to as the
Project) called the "First Party" though Shri
which expression shall, unless repugnant to the context or meaning thereof, include its successors-in-
office and permitted assigns) of the 'First Part', and
The Managing Director, Him AgriVision Producer Company Ltd. (HAVi) a company registered under
the Act vide registration number
dated having its registered office at here-in-after called as
"Second Party" which expression shall, unless repugnant to context or meaning thereof, include its
successors, representative and permitted assigns of the 'Second Part'.
The objective of this MOU is operation and maintenance of Collection Centers/Retail Outlets,
Machinery Equipments and assets created under the Project in Collection Centers/Retail Outlets.
This MOU shall be regulated by the following terms and conditions:-
1) That the First Party is the rightful owner of Collection Centers/Retail Outlets established under
H.P. Crop Diversification Promotion Project JICA-ODA Project at various places of Himachal
Pradesh i.e Hamirpur, Sundernagar (Mandi), Birta, Paprola, Bhatoo (Kangra) and Auhar
(Bilaspur) Himachal Pradesh.
2) That the Second Party is interested to take over operation and maintenance of these Collection
Centers/Retail Outlets and want to utilize Collection Centers/Retail Outlets established by the
First Party along with the machinery installed therein.

- That the Second Party has a valid registration under the Companies Act, 2013 as per the documents submitted by the company.
- 4) That the assets which will be handed over by the First Party to the Second Party in accordance with this MOU shall be maintained in accordance with the provisions mentioned herein.
- 5) In case the Second Party fails to comply with the basic objective of the said Collection Centers, the First Party shall have legal right to cancel the said contract by giving one month notice to vacate and handover the premises to the First Party.
- 6) That the machinery which has been installed by the First Party will remain under the rightful ownership and supervision of the First party and the Second Party will be fully responsible for any damage caused to the same and bear the cost of its maintenance, repairs, electricity charges, water charges, running cost of machines. Till the machinery is under the warrantee, First Party shall direct the suppliers to fulfill its obligations.
- 7) The Second Party shall also bear the expenses on account of cleanliness of premises, watch and ward safety/security of assets and also local taxes/municipal taxes, if any.
- 8) That the Second Party shall have no legal right to make any alteration in the Collection Centers/ Retail Outlets without the prior permission of the First Party.
- 9) That the First Party will not be responsible for any illegal acts which would be committed by the Second Party during the course of their work i.e failure of sample, quality of food etc. under the Prevention of Food Adulteration Act, 1954 (Amended upto 1986).
- 10) That the Collection Centers/Retail Outlets will be given only for 11 months and if the Second Party desires to continue with the same in future, then the Second Party will approach the First Party in writing one month before the expiry of the said period for extension of period of subsistence of this MoU.
- 11) The Second Party shall use the facility for storage, processing, value addition, marketing of agricultural products (raw as well as finished products) only and the premises shall not be used for any commercial activity.

- 12) That the Second Party shall be responsible for the loss/theft of any asset maintained by the Department.
- 13) First Party shall nominate its representative to each Collection Center who may visit the Collection Center/ Retail Outlet at any time during the working hours. The representative so nominated shall submit monthly report to the First Party regarding compliance of terms and conditions of the MoU by the Second Party it rendered.
- 14) That the facility of processing, value addition, storage in cold chamber in Collection Center/Retail Outlet shall be available to the Farmers/Self Help Groups (SHG)/Farmers Organizations (FO)/ Krishak Vikas Associations (KVAs) of Phase-I and II of the project on nominal charges to be fixed by the First Party in consultation with Second Party, on no profit no loss basis.
- 15) That the list of inventory (Annexure A) which has been installed by First Party along with the building of Collection Center/Retail Outlet shall be properly handed over and taken over by both the parties at the time of signing of this MOU. The ownership of the land on which the Collection Centers / Retail centers have been constructed and the Collection Center/retail outlet shall continue to remain with the Agriculture Department, Himachal Pradesh. The total value of fixed and movable assets of six Collection Centers /Retail Outlets is Rs. 563.75 Lakh (Fixed assets Rs. 367.07 Lakh + movable assets Rs. 196.68 Lakh) as per Annexure 'A'.
- 16) That if the Second Party is unable to continue withthe MoU under any circumstances, or there is breach of provisions of this MoU then the First Party shall issue one month notice to the Second Party and provide a cure period of 15 days or any longer period taking into consideration the nature of default, to make its representation, if any. In case Second party fails to comply directions within stipulated period then the Second Party shall be liable to return the said premises along with machinery/equipments as per inventory in the running condition free of any liability to the First Party after satisfaction of the first party.

- 17) That prior to handing over, the Collection Centers/ retail outlets by First Party to the Second Party, the Second Party shalldeposit the Security amount of Rs. 5.00 Lakhs in the shape of FDR duly pledged with the First Party and if the Second Party fails to comply with the terms and conditions of the MoU, then the security amount will be forfeited or any other pending liability in case assets/maintenance etc. are taken back by the First Party shall be recovered from the security amount.
- 18) That the Second party shall give bank guarantee @ 25 % of the value of the machinery (Rs. 49 Lakhs) i.e. the cost of machinery/ equipments and other fixtures installed by the First Party in the Collection Centers (Total value of machinery Rs. 196.68 Lakh) Annexure 'A' before taking over the possession of premises after signing of MoU.
- 19) That this Memorandum of Understanding will only be amended/modified under extreme circumstances in writing by mutual consent of both the parties.
- 20) That in case any dispute arises between the First Party and Second Party then the same will be settled amicably with each other failing which the same shall be referred to the Civil Court having jurisdiction to try the same.
- 21) That the Second Party shall submit financial disclosure before signing the MOU.



In the 17<sup>th</sup> meeting of Executive Committee (EC) of JICA project held on 4 December, 2020, it was decided that Project Management Unit (PMU) shall continue up to June, 2021 which shall coincide with starting of Phase-II project. This will help in smooth transition from Phase-I to Phase-II and avoid the losing of experienced and trained staff of Phase-I. 84 persons were working at that time. The project has appointed outsource agency for providing staff in Phase-II after following JICA Procurement guidelines. The outsource agency was asked by the project to reappoint the outsource staff of Phase-I. Accordingly, the outsource agency i.e. Farm Technocrats Forum (FTF) in June, 2021 reappointed 84 persons in Phase-II for 3 months provisionally who were working in Phase-I after the EC accorded approval in its first meeting held on 5<sup>th</sup> May, 2021.

During scrutiny of documents of this staff, it was observed that in some cases, there is variation in qualification as per details given at 'Flag-A'. Since they are working on the same post from Phase-I, therefore they may be allowed to continue by giving onetime relaxation in essential qualification in view of their experience in Phase-I and this will be got ratified in the next meeting of Executive Committee which is competent to revise qualification, experience etc. of outsource staff. This is necessary because the contract of these persons is up to 31st August, 2021.
